Five lines of development in the theory of probability (page 124). The mathematical notion and its initial problems. An unsolved problem. Laplace's condition of equal possibility. From Laplace to Poincaré. Summation and product of probabilities; Bayes' theorem.

The logical notion of probability; positions of Keynes, Jeffreys and Harrod (page 131). Logical formulation of summation and product of probabilities, and of Bayes' theorem. Prior probability in Bayes' theorem. Criticism of Bayes' theorem as the basis of induction. Attempts, from Bayes to Fisher, to overcome the objections. Justification by Jeffreys. Mortara's view of probability as frequency. Von Mises' Kollektiv. Castelnovo on probability and randomness. Subjective concept of probability; mathematical formulation. Concentrated and continuous probability. Subjectivity in science and probability. Subjective probability of historical entities; objective probability of classified events. Pragmatic justification of the objective theory. Carnap's view of probability as degree of confirmation and as relative frequency.

Syntactic and semantic analysis of theories (page 196). Statistics and Metastatistics. The distinction between logic and psychology. Statistics faced with the variety of scientific disciplines.

Axioms as a beginning (page 198). Axioms and theorems. Extensions to the factual disciplines. True, false, and probable in the factual disciplines.

Syntactic analysis of statistical induction (page 202). The formation of "cases" and of statistical data. The provisional nature of classification: new botanical species; syntactic rules; strange particles; inflationary economic recession; evolutionism and Mendelism.

From induction to hypothesis: the intuition of genius (page 208). Scientific explanation. Explanation is a formulation of the *quia*. Pragmatic truth and *noscendi cupiditas*. Hypothesis and the enunciation of a theorem. Errors and tests of significance. Economic justification of the simplest laws. The positivistic and the modern view of laws. Historical character of laws. Heisenberg on the unifying function of laws. Wittgenstein's view of explanation as conceptualization. Summary notes. Democritean and Machian orientation in science. Rejection of dualism. A warning from Jeans.
