REMARKS

- 1 The Questions entrusted to each Study Group for the Study Period 1989-1992 can be found in Contribution No. 1 to the Study Group.
- 2 The strict observance of the specifications for standardized international signalling and switching equipment is of the utmost importance in the manufacture and operation of the equipment. Hence these specifications are obligatory except where it is explicitly stipulated to the contrary.

The values given in Fascicles VI.1 to VI.14 are imperative and must be met under normal service conditions.

For reasons of economy, the Recommendations in this Fascicle have been reproduced without modification from the text of the *Green Book*, with the exception of Recommendations Q.126, Q.155 and Q.161 which have been deleted and Recommendations Q.141 and Q.180 which have been slightly modified. Therefore, when reference is made to Recommendations not contained in this Fascicle, the *Green Book* or later CCITT Books should be consulted.

CCITT NOTE

In this Fascicle, the expression "Administration" is used for shortness to indicate both a telecommunication Administration and a recognized private operating agency.
