CONTRIBUTORS

Mary C. Brinton is the Reischauer Institute Professor of Sociology at Harvard University and Director of the Reischauer Institute of Japanese Studies. Her current work focuses on why several regions of the post-industrial world – East Asia, Southern Europe and Eastern Europe – now exhibit historically low fertility rates that are leading to rapid population ageing and the prospect of lowered economic productivity. She has published several articles on this topic and is working on a book manuscript titled *The Gender Bargain*, a comparative study of gender inequality and fertility that combines quantitative analysis with original in-depth interviews of young urban adults in four countries.

David Chiavacci is Professor in the Social Science of Japan at the University of Zurich, Switzerland. His research covers political and economic sociology of contemporary Japan in a comparative perspective. His main focus is on social movements, social inequality as well as on Japan's new immigration and immigration policy. His recent publications include *Re-emerging from Invisibility: Social Movements and Political Activism in Contemporary Japan* (Routledge, 2018, co-edited with Julia Obinger) and *Japanese Political Economy Revisited: Abenomics and Institutional Change* (Routledge, 2019, co-edited with Sébastien Lechevalier).

Giorgio Fabio Colombo is Professor of Comparative Law at the Graduate School of Law at Nagoya University, where he is in charge of comparative private law. He has taught and done research in Italy (Pavia, 'Ca' Foscari' Venice, Palermo), Japan (Ritsumeikan, Kyoto) and the United States (UC Berkeley). He has advised the Law and Justice Commission of Pakistan on arbitration. His recent publications include *Hybridizations, Contaminations, Triangulations: Itineraries in Comparative Law through the Legal Systems of Italy and Japan*, Special Issue of the *Italian Law Journal* (2018, editor) and *Law and Opera* (2018, co-editor with Filippo Annunziata).

Laura Dales is Senior Lecturer in Asian Studies at the University of Western Australia. Her research interests include gender and friendship broadly as well as singlehood, happiness and marriage in contemporary Japan. Her recent publications include the edited collection (with Romit Dasgupta and Tomoko Aoyama) *Configurations of Family in Contemporary Japan* (Routledge, 2015), as well as chapters in the books *Intimate Japan* (Alexy & Cook, eds., 2018) and *Happiness and the Good Life in Japan* (Manzenreiter & Holthus, eds., Routledge, 2017). She is currently working on a project examining intimacy beyond the family in contemporary Japan.
