<i>A new library school graduate accepts a cataloging position in a research institute library, only to discover that much of her work will involve the typing of cards and other records.</i>

The cataloging staff in a university library gets along so well that the amount of time devoted to work is being eroded by socializing, and the newly appointed chief of cataloging must reverse this trend.
7. A PAPERBACK DILEMMA 38
The head of the public services department in a public library wants to set up a paperback browsing center at the building entrance, but encounters objections from the heads of the order and cataloging departments.
8. THE LOST CATALOG TRAY 45
One of the card file drawers in a high school library mysteriously disappears, and the library staff must decide how to reconstruct it.
9. CLASSIFICATION CHANGES CAUSE SPLIT SHELVING 52
A library-minded professor in the religion department of a developing university objects to the dispersal of ecumenical materials in two Dewey numbers.
10. THE NEW LIBRARY TECHNICIAN ARRIVES 58
A public library has agreed to employ a technician in training at the local technical institute, but he proves to be inaccurate in his work and unenthusiastic about his job.
11. THE MICROFILM NEVER GETS CATALOGED 65
When a student needs to use some of the stored but uncataloged microfilm in the seminary library at night, he is told that he must come back during the day because the film is locked in the cataloging area.
12. AN AUTHOR FINDS HIS BOOK MISCLASSIFIED 72
A visiting scholar from France checks the university library catalog

and discovers that his own book has been given a wrong classification number and subject entry.

13. "THE CHECKING FILE DISAGREES WITH THE CATALOG ENTRY" 78
The lack of entries for periodicals in the catalog of a growing public library causes problems for the patrons, but there seems to be no easy way of solving the problems without encountering equally difficult new ones.

When the information services librarian for a bank decides to move to another job, her successor has trouble discovering the principles of the new classification scheme which she had worked out to fit the needs of the special library.

16. WHY CATALOG THE ENTIRE SERIAL FOR JUST ONE ISSUE? 98
The head of the economics department in a university places orders for sample issues of periodicals and does not understand when a cataloger tries to explain why the issues should not be cataloged.

17. "A MISFILED CARD IS A LOST CARD" 104
An attempt at applying management principles to the card filing routine in a university library appears to result in a drastic increase in the number of misfiled cards, to which the reference staff objects.

18. THE BEST BOOKS TAKE LONGER TO GET CATALOGED . . 108
A book in demand by public library patrons remains uncataloged; when it is requested by the reference department, the head cataloger

discovers that he cannot retrieve it quickly from his wife, to whom he had taken it over the weekend.

<i>In a large university library, the bindery procedure for periodicals involves shelflisting the volumes before binding them; but during that time, the circulation department has no record of them.</i>

<i>The change from Dewey to the Library of Congress Classification in a university library appears to cause a graduate student to overlook some material relevant to his thesis, and causes the library's advisory committee to demand that the collection immediately be completely reclassified to LC.</i>	
21. A COOPERATIVE PROCESSING CENTER DEVELOPS A BACKLOG	127
<i>A regional processing center for public libraries loses its librarian; the new administrator arrives to find the center far behind in its work and the member libraries threatening to withdraw.</i>	
22. THE SERIALS CATALOG BECOMES MACHINE-READABLE	133
<i>A university library serials cataloger, in favor of automating the holdings record, finds herself opposing the progress of the conversion project in view of the inaccuracy of the current record.</i>	
23. LOCAL REVISION OF LC SUBJECT HEADINGS	139
<i>The newly appointed social sciences subject cataloger for a university library argues that the Library of Congress is too slow in updating its subject headings; she wants to tap the local scholarly community for a project in revising the sociology headings.</i>

<i>The state library staff attempts to devise a plan for a union catalog in book form, but arguments develop about the format, procedures, and location for the union catalog staff.</i>
